South African and foreign visitors and boarders who were in the household on Census night, should all be counted as part of the household. Additional information regarding the completion of the questionnaire is contained in the accompanying information sheet.

Domestic workers and live-in employees are regarded as separate households. They should therefore complete separate questionnaires.
